Seniority list of Beat Forest Officers working under Eastern Circle, Palakkad has been published as per the Order under reference 1<sup>st</sup> & 5<sup>th</sup> cited.

6 vacancies of Section Forest Officers are now existing due to the retirement, which are to be filled up by promotion.

As per reference 2<sup>nd</sup> & 4<sup>th</sup> concerned officers have reported that there is no objection in promoting the following Beat Forest Officers as Section Forest Officers.

Disciplinary actions against Sri.K.K.Maruthan under Serial No.197, Sri.Kalimuthu under Serial No. 199 & Sri.V.Gopalakrishnan under Serial No.203 are pending. Hence they are not considered for promotion and Sri.C.V.Perumal under Serial No.201 has expired.

On verification, it is found that all the above 6 (six) Beat Forest Officers under Serial No. 195, 196, 198, 200,202, 204 in the seniority list, have undergone the Forest Guard's Training and their probation has been declared in the cadre of Beat Forest Officer and hence they are found eligible for promotion.

In the above circumstances, it is hereby ordered that the above Beat Forest Officers are provisionally promoted as Section Forest Officers as per Rule 31 (a) of KS & SSR 1958 and the Rules subsequently amended and subject to reversion when vacancies cease to exist and also subject to any other contingencies warranting such action.
